POOL RULES AND REGULATIONS

For the protections and enjoyment of all residents of
Rolling Acres

ALL PERSONS USING ROLLING ACRES RECREATIONAL FACILITIES DO SO AT THEIR OWN RISK. ROLLING ACRES IS NOT RESPONSIBLE FOR ANY ACCIDENTS OR INJURIES TO PERSONS OR PROPERTY IN CONNECTION WITH SUCH USE. ROLLING ACRES IS NOT RESPONSIBLE FOR LOSS OR DAMAGE TO ANY PERSONAL PROPERTY. ALL INJURIES SHOULD BE REPORTED TO THE POOL OFFICE WHERE FIRST AID IS AVAILABLE.

To assure the enjoyment of all residents, guests may use the pool only in the company of the residents - with a limit of two (2) guests per resident on weekdays only and only if the manager allows.

No one (1) adult may watch more than four (4) children at a time. ***this includes their own children*** The adult must register the person by name and state that they are responsible for the person or persons.

The pool manager has the authority to restrict pool privileges to any resident.

ALL CHILDREN UNDER 14 YEARS OF AGE MUST BE ACCOMPANIED BY AN ADULT OVER THE AGE OF 18. IN SOME INSTANCES, PROOF OF AGE MAY BE NECESSARY. NO INDIVIDUAL MAY SWIM ALONE.

Use of any toy, flotation devices, etc. must be approved by the pool manager.

NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE POOL AREA. NO FOOD, GLASSWARE OR BOTTLES IN THE POOL AREA. SMOKING IS PERMITTED, PROVIDED THAT THE BUTTS ARE DISPOSED OF PROPERLY, IN THE FURNISHED CONTAINERS.

Only suntan lotions with low oil content are allowed. Shower off any tanning product before entering the pool. No jewelry or t-shirts are to be worn in the pool.

NO PETS IN THE POOL AREA.

Infants must wear plastic or rubber pants over their diaper when in the pool.

Admission to the pool shall be denied to persons suffering from obvious diseases and or injuries to the skin, eyes, ears, or respiratory tract unless exempted by an appropriate medical certificate.
